Terms

I, the undersigned, hereby acknowledge that I desire to participate in the gaming tournament held at the location of 517 Marine View, Suite J, Belmont, CA ("The Location"), on April 27–28, 2018, known as BoMB & Friends Spring LAN 2018 ("The Event"). I acknowledge that my decision to participate in The Event is entirely voluntary and is solely for the purpose of my pursuit of recreational activities that I enjoy. I am of sound judgment and capable of understanding the risks involved in participating in The Event.

Indemnity

I hereby assume all risk of illness or personal injury involved in The Event in which I participate. For and in consideration of permission to participate in The Event, I hereby irrevocably and unconditionally forever release, discharge, indemnify, and hold harmless Joe "FlameHeart" Weaver ("The Organizer"), as well as any other organizers, affiliates, or sponsors of The Event, including the owners and renters of The Location, and each of their officers, directors, employees, stockholders, members and agents (each, a "Released Party") from any and all claims, losses, causes of action and liabilities of any kind, including attorneys' fees, (including but not limited to, actual, compensatory, and punitive damages), arising out of or relating in any way to The Event. I voluntarily waive any claims that I might have against any Released Party, and I understand and agree that the Released Parties assume no responsibility or liability for any injury to persons, or lost, stolen or damaged property, that may occur during or resulting from The Event.

Conduct

I further hereby agree that during The Event, I shall conduct myself in an appropriate fashion and I shall not behave poorly by performing harmful acts, using excess profanity, obscenity, or any otherwise objectionable conduct towards any person or property involved with The Event or The Location.
